BODYBUILDING SOUTH AFRICA – UPDATE ON SHOW CALENDAR 2021

Dear IFBB Family

Hope everybody is safe and healthy and taking precautions protecting loved ones and people around you.

We still find ourselves in a time of challenges and uncertainty where the Covid pandemic is testing us all to an extreme with the ability to cope mentally, physically, and financially.

According to our plan for 2021 we purposely decided not to engage with any events in the first and second quarter of the year believing that Covid circumstances would improve and as published, intended on running events from June to December 2021.

With the effect of the announcement on Sunday night by our President, moving the country to Level 4 as circumstances around the Covid is profoundly serious especially in Gauteng, and we see an increase of Covid cases nationally. The impact of restrictions on gatherings is one part we believed we could manage but, closure of our gym and fitness centres for 14 days has a direct impact on our athletes preparing for the shows.

We also take into consideration that first and foremost our position as a federation on the running of shows would be a priority to keep the health and safety of everybody involved.

Last night, in an urgent special general meeting, it was decided by the council we do not intent to cancel any shows at this stage but believe and stay positive that with the improvement of the Covid protocols and regulations nationally the situation will improve. We will for now push forward the calendar of events and dates by 4 weeks.
